

Moses Sabfoil Warning, Safety Precautions and Warranty Information

WARNING & SAFETY PRECAUTIONS

Hydrofoiling is inherently a dangerous activity that can cause serious injury or death to you or the people around you, regardless of whether a SABFOIL or another brand product is used. These risks include drowning or being hit by the product if control is lost. The risk of injury to the user or surrounding people may increase if an external structure of any kind is added to it, which could increase the possibility of hitting people and / or things, increase the speed at which the hydrofoil can be operated, or change the way the product reacts when it comes into contact with water or soil during an out-of-control situation.

Based on what you have read so far, you declare that you understand that the use of this product and/or participation in a sport or any activity related to foiling could cause injury or death to you and / or others around you.

By assembling any component of this product, the user declares to have read and understood the following terms and conditions, and agrees to be bound by them:

1. Always observe local rules and regulations when using this product.
2. Read the user manual carefully for important information on the installation, care and maintenance of the hydrofoil before use.
3. The use of this product exposes the user to unexpected and unavoidable risks and dangers.
4. The user is responsible for his safety and the safety of those around him.
5. It is the user's responsibility to inspect the equipment for wear before each use.
6. It is the user's responsibility to perform regular maintenance on this product.
7. Never use damaged or broken products.
8. Do not use this product if you are not in good physical health.
9. Do not use this product unless you are an experienced swimmer.
10. Do not use this product under the influence of alcohol, drugs or medications.
11. Never use this product in shallow water, near shore, piers, swimmers or for other out-of-water activities.
12. Never use this product in conditions that exceed your level of skill and experience.
13. Do not use this product in thunderstorms and/or lightning conditions.
14. Always wear an approved life jacket and protective jacket.
15. Always wear a suitable safety helmet.
16. This product is designed for use on water only.
17. The components of this product are subject to the random forces of natural elements and uneven wear.
18. Use only original SABFOIL spare parts.
19. Always use extreme caution and pay attention when using this product.
20. If you are not an experienced user, be sure to take lessons before using this product in the water.
21. Always navigate under control and do not use at speeds that exceed your capabilities.

22. Before use, make sure that bolts and screws are tightened with the correct torque, as described in the user manual.
23. The minimum age for using this product is 18 years. In the case of a minor user, the approval and supervision of a parent or legal guardian is required.
24. Temperatures above 650°C can cause the decomposition of carbon fiber into breathable fiber particles (WHO-fibers). Do not inhale the combustion gases in case of fire.
25. SABFOIL is not responsible for injury, death or damage to people, things and/or to the product caused by improper use or not in accordance with these instructions.

Failure to observe the above warnings and precautions may increase the risk of serious injury or death to yourself or surrounding people, damage to the product, or both.

WARRANTY POLICY SABFOIL certifies that the warranty of this product is valid for 24 months from the date of purchase within the European Union (EU) and for 6 months outside the EU, as defined by the Consumer Protection Act. SABFOIL warrants that this product is free from major defects in materials and / or workmanship. If the customer is a company, it is required to immediately inspect the goods supplied for non-conformances in terms of quality and defects and to communicate this within 2 weeks of receipt of the goods by writing to the SABFOIL headquarter. Otherwise, the claim of warranty rights will not be granted unless there are proven reasons. By assembling and/or using any component of this product, the customer declares to have read and understood the terms and limitations of this warranty, accepting the following:

1. The warranty of this product is valid for 24 months from the date of purchase within the European Union (EU) and for 6 months outside the EU, as defined by the Consumer Protection Act.
2. The warranty is valid only when this product is used for normal sporting and recreational activities, and does not cover products used in rental or teaching operations.
3. Damage caused by misuse, abuse, neglect or normal wear and tear is not covered by this warranty. These types of damage include (but are not limited to): punctures, damage from coupling with non-original SABFOIL components, damage due to excessive exposure to the sun, damage caused by improper handling and storage, damage caused by use in excessively large waves or from hitting rocks or seabed, damage caused by hitting the foil at high speed, damage caused by excessive jumps or stunts or damage caused by anything other than defects in materials and/or in processing.
4. SABFOIL will make the final determination of the warranty. It may require the customer to send to the SABFOIL head office or to an official distributor of SABFOIL in their country (prepaid postage) of multimedia material of the equipment that clearly shows the type of defect and / or malfunction. A direct inspection of the product considered defective by SABFOIL or an official SABFOIL distributor/shop may also be required.

5. If a product is found to be defective by SABFOIL, the warranty only covers replacement of the defective product. SABFOIL will not be liable for any costs, losses or the repair or damages incurred as a result of using the defective product.

6. The product can only be returned with prior authorization for return from the SABFOIL headquarters.

7. The warranty for any repaired or replaced component is valid only from the original purchase date. The original purchase receipt must accompany all warranty claims and the retailer's name and the date of purchase must be clear and legible.

8. This warranty has no value if unauthorized repairs or modifications have been made to any component of the equipment.

9. There are no warranties that extend beyond the warranty specified here.
